



2017 GOLF CART/ATV REGULATIONS

The information listed within provides guidance regarding the valid usage of golf cart or atv type vehicles hereinafter referred to as golf carts/atv's at Lucas Oil Speedway. Operators of golf carts/atv's understand that they do so at their own risk, and will relieve and hold harmless Lucas Oil Speedway for any and all debts that might occur from theft, accidents, and/or injuries involving the use of the golf cart/atv. These regulations have been designed to provide a safe and friendly environment for all persons attending events at Lucas Oil Speedway. Thank you for your cooperation.

2017 GOLF CART/ATV RULES AND REGULATIONS

Hickory County Sheriff Brian Whalen issues this reminder- Missouri Motor Vehicle Law may PROHIBIT golf carts/atv's from being on ANY public roadways at ANY time. Violators may be cited and fined accordingly.

A. GENERAL RULES

1. Operators must be 16 or older and hold a valid driver license.
2. All golf carts/atv's on Lucas Oil Property must prominently display an official 2017 Lucas Oil Speedway golf cart/atv permit on the left front of unit at all times.
3. Golf cart/atv and driver must be present to receive a permit from Security/Camp ground office.
4. Golf carts/atv's intended to be used after dark shall be equipped with headlights or other sufficient lighting sources.
5. Golf carts/atv's **may not** be operated during designated "quiet times" (1:30am-6:30am) as announced by Lucas Oil Speedway Officials.

B. OPERATION OF GOLF CARTS/ATV'S

1. Golf carts/atv's are not to be operated in a manner that may endanger passengers and/or any other patrons on the grounds of Lucas Oil Speedway. **Maximum Speed Limit is 7 mph.** Excessive speeds will not be tolerated. Operators must yield to pedestrians at all times.
2. No one under the influence of alcohol may operate a golf cart/atv.
- 3. No overloading of passengers on golf carts/atv's. No hanging, No riding, No standing – the number of seats equal the maximum number of passenger(s).**
4. Golf carts/atv's are restricted to the designated driveways and paths within the parking lots of Lucas Oil Speedway and designated roads in camp grounds. There shall be no driving on public roadways, landscaping, etc. Golf carts/atv's may not be chained to any trees, signposts, etc.
- 5. NO DRIVING ON THE RACETRACK OR ANY OTHER LUCAS OIL SPEEDWAY PROPERTY NOT DESIGNATED!**
- 6. Rental golf carts will also obey by all rules and regulations set forth.**

C. PARKING REGULATIONS

1. Golf carts/atv's can only be parked within areas designated by proper signage and/or as announced over the Lucas Oil Speedway public address system.
2. Golf carts/atv's must be parked within these areas in such a fashion that they do not block or impede entrance to buildings, stairways, or designated handicapped areas.

Violation of these regulations will result in revocation of privileges and operating permit and may result in golf cart/atv being impounded for the remainder of the event, and possible expulsion of the operator from the property with NO REFUND. LUCAS OIL SPEEDWAY IS NOT RESPONSIBLE FOR ANY ACCIDENTS-INJURIES-THEFT ASSOCIATED WITH THE USE OF A GOLF CART/ATV AT LUCAS OIL SPEEDWAY.
